If you competed in Acura Key West 2007 or 2006 and your boat is in the identical configuration, you are not required to submit a 2008 PHRF handicap application and pay the fee. However, this renewal application must be submitted as supporting documentation.

The Key West PHRF Consortium reserves the right to assign a different handicap than the one assigned in 2007. It is imperative that the boat owners read and comply with the current PHRF Rules and Regulations.
